## 2023 Year-End Reflections

IADG began the year with three program priorities: marketing to attract business development projects, providing financial and technical expertise to support business growth, and delivering educational and capacity-building opportunities for our members and communities. While we're still collecting some year-end statistics, here is an overview of how IADG delivered on all three aspects.



Despite a slowing economy and rising interest rates, IADG opened 133 new projects in 2023. Of these, 89 or 67% of the projects were classified as business development, and the rest were community-focused projects. From an industry perspective, 30% were related to manufacturing, 25% to agriculture and food processing, and 15% were classified as warehouse distribution. IADG was asked to assist as part of a new location project 62% of the time, which is a testament to IADG's marketing efforts and outreach.

Impactful financial and technical assistance is demonstrated through another record-setting year for USDA REDL&G awards, receiving over \$41M in 2023 (\$11.4 million more than 2022, which was also a recordsetting year). As a result, almost \$4.5M in awards and local matching funds were added to local utilitymanaged revolving loan funds. IADG works with its sponsoring utility members and the business to compile the information and

submit the comprehensive application to USDA.

The IADG Energy Bank RLF continued to issue loans as funds became available. IADG also assisted with the marketing effort to launch Region XII's \$15M lowa Meat and Poultry Loan fund. With food processing as a target industry, IADG's President, Bruce Nuzum, chairs the loan review committee for the fund, which has approved \$14M to date.



IADG hosted its **Partners Forum** in October. This two-day event brought together **120 key partners** to hear from economic development experts and learn from each other. The IADG team received overwhelmingly positive feedback about the Forum.

IADG also partnered with Corn Belt Power Cooperative on a Value-Added Agricultural Industry Roundtable

session focused specifically on food processing and fuels and grain processing. Business and association leaders offered invaluable insights into the present and future state of the industry to help pinpoint impacts and opportunities moving forward.

As IADG begins the new year, we will maintain our focus on marketing and business development efforts with a full trade show schedule and the continuation of our prospecting efforts.

## Congratulations to the 2023 Iowa Venture Award Recipients!

Cold-Link Logistics "Outstanding Business of the Year," established in 2016 by the Mandich brothers, has evolved into a family-driven, full-service logistics company with over 200 employees across five states. Their strategic expansion to Sioux City in 2021 resulted in a



189,000 sq. ft. cold storage facility, fostering partnerships with major clients, including Wells Blue Bunny and Purdue Premium Meats. A 155,000 sq. ft. expansion is planned to begin in 2024. The company prioritizes family values, innovative cold chain solutions, and a commitment to employee well-being.

**Centro, Inc.**, a company based in North Liberty, had expanded its operations by acquiring a 30,000 sq. ft. building in the Hampton Air Industrial Park, making it their 11th location. The new facility houses two rotational molding machines and has employed 40 new



associates, aiming to bolster production capacity across the Midwest to meet increasing demand. This expansion and a 2021 similar project in Cascade reflect Centro's growth strategy and commitment to serving various industries, including agriculture, construction, and lawn & garden sectors.

**HiPer Ceramics**, launched in 2018 by Ann Kathryn Hoffmeister, specializes in high-performance ceramic materials for industrial components and hip implants. Operating from a 16,800 sq. ft. facility in Spirit Lake, the company prioritizes quality, automation, and



cost-effectiveness, collaborating with German partners for precision and safety in medical and industrial applications. Hoffmeister's roots in the Iowa Lakes area, reliable and affordable energy, and strong community outreach were key factors in this first U.S. location.

Ihle Fabrications, founded in 2002 by brothers Mike and Brian Ihle, began by fabricating liners to address their own combine issues, then those of their neighbors. The company



has since grown, relocating to a 45,000 sq. ft. facility with an 82,000 sq. ft. expansion underway. Their products, including wearable steel parts for agricultural machinery, are sold nationally and internationally. In 2022, Ihle Fabrications became a certified CNH Reman supplier, expanding its production significantly. Ihle Fabrications remains committed to solving future farming challenges.

M3 Fabrication, founded in 2014 by the McClure brothers, is a family-owned metal fabrication company in Bloomfield, lowa. In May 2022, it expanded by acquiring a similar fabricator, added a 50,000 sq. ft. building, and made equipment and process



upgrades. Specializing in stainless steel, aluminum, and mild steel fabrication, M3 emphasizes high-quality craftsmanship, personalized service, and on-time delivery. The company's growth and commitment to excellence reflect its entrepreneurial heritage and community orientation.

Post Equipment Company, based near Rock Valley, has grown into a successful farm equipment supply company since relocating from the family farm in 2008. It offers a wide range of new and used farm equipment, replacement parts, and specialized livestock



equipment. Additional companies co-located include Post Metal Recycling, offering industrial and on-site scrap metal recycling services, and Ironwood 53 specializing in designing and producing agricultural and industrial parts, manufacturing the "Herd-Boss Feeders" line of OEM cattle feeding equipment for export.



# IADG Energy Bank Supports Efficiency

The IADG Energy Bank continues to show great results. To date, the nearly \$2 million Revolving Loan Fund (RLF) has **supported 23 projects**, with additional awards being made as loans are repaid.



Kol-Gol, located in Waukon, is a manufacturer of specialty wire formed display equipment, including store displays, agriculture uses, gardening products, and custom designs. The company is a recent recipient of a loan from the IADG Energy Bank, accessing the program to purchase a new Bodor Fiberglass Laser System. This new laser cutter will replace several pieces of older equipment, streamline manufacturing, and reduce the outsourcing of processes to other companies, which will reduce transportation costs. In 2015, Kol-Gol, Inc. also utilized an IADG Energy Bank loan to procure and install an automated metal roller saw, which has since been fully repaid.

## Ripple Effect Fosters Change

**Webster-Calhoun Cooperative** Telephone (WCCTA) and Aureon contributed \$5,000 each for preconstruction costs associated with a \$700,000 expansion and remodel project of "The Kid's Spot" child care center in Lake City. The Ripple Effect grant, other local funding, and a Future Ready Iowa Child Care grant have helped The Kids' Spot make room for 30 childcare spaces and 6 more full-time employees. The expansion consists of a 2-room addition, restrooms, washing stations, outdoor space, new playground equipment, and safety updates such as security enhancements, fire systems, and safe exits.



**Titonka-Burt Communications (TBC)** offered a \$1,500 contribution, matched by Aureon, to help the We Care Childcare Committee in Titonka pay for architectural drawings needed for remodeling an existing space into a childcare center. Once completed, it is anticipated that the center will offer daycare space for

40 children and before/after school space for 15 to 20 children. We Care Childcare will employ an estimated seven full-time staff members and nine part-time staff members.

City leaders and Lone Rock Depot Volunteers received a combined total of \$10,000 in Ripple Effect funding from **Lone Rock Cooperative Telephone**.

The community is in the process of making major improvements to the Lone Rock Depot site, and the funding will be allocated towards costs for site improvements. The depot, located next to the actual "lone rock" that originated the city's name, represents the heart and soul of how Lone Rock has come to be. In August of 2024, the city will be celebrating its 125th Anniversary, and the newly remodeled depot site will be the centerpiece of the celebration.

## **Making Connections to Grow Business**

It is an IADG priority to actively market lowa as a state to grow or expand business. This multifaceted marketing effort includes trade shows, business prospecting programs, electronic marketing of sites and buildings, and direct marketing and contact.

IADG has an aggressive **2024 trade show schedule**, with the industry targets of food processing/manufacturing, poultry, dairy, and indoor agriculture/Controlled Environmental Ag. (CEA). The IADG team coordinates the booth and logistics of the shows and is then joined by IADG members for the onsite promotion. Trade shows provide an excellent opportunity to meet prospective companies that may expand to lowa and reconnect with lowa's existing businesses to discuss their plans for the future and determine how the IADG members network can be of assistance.



IADG continues a **prospecting program** that started in 2021. Partnering with Research FDI, a new campaign will kick off in early Spring with the goal of identifying ten companies with an interest in doing business in Iowa and generating an additional pipeline of prospects for the future. Cold-Link Logistics, the new 189,000 sq. ft. cold storage facility in Sioux City and 2023 Iowa Venture Award "Outstanding Business of the Year," was identified through a similar campaign in 2021.
